The Town of Leesburg has contracted with the Engineers & Surveyors Institute to provide a Minimum Submission Review (MSR) for Final Site Plans, Final Subdivision Plats, Preliminary Subdivision Plats, Construction Plans and Rough Grading Plans. The purpose of the Town of Leesburg ESI Review Program is to improve the quality of the plans being submitted, shorten the review times for applicants and Town staff, reduce the amount of review required and achieve a more predictable process of plan approval. The information requested below is used only to track the plan and ensure that the Applicant's fee is properly applied to this project. Once the plan and fee are received, the ESI review process will commence. The Applicant's fee covers two (2) reviews of the submitted project. All subsequent submissions are subject to a \$1200.00 fee per submission.

**Instructions: Please provide requested information below. Once completed, please print the filled application, sign and date the Agreement portion, then submit the application and fee payment with your plan submission to the ESI Chantilly office. This application will auto-calculate the initial fee for the project, which will cover two (2) reviews (see "Total Due" field below). Third submissions or higher are \$1200.00 per submission. If paying by check, please make the check payable to "ESI Peer Review" and submit it with the application. If paying by ACH, please send payment to the ESI account listed under "ACH Information."**

Project funds provided by the Applicant to ESI for administrative and review services become the sole property of ESI as compensation for and payment of contracted Peer Reviewers. ESI invests valuable resources to become thoroughly familiar with the project and then ensure a timely, expedient and accurate review. Consequently, ESI will not consider a request for a prorated refund if the Applicant withdraws the project any time after first submission comments have been provided. A request for refund due to withdrawal of a project prior ESI's first submission review may be considered at the discretion of the Director of ESI.
